intervention through an effective regulatory mechanism(s) to protect and conserve the bio diversity of

endanger species in particular and the whole environment in general.

The second article is an analysis on how one particular group of villagers called 'saving group' tries to be

better off through self-help mechanism which is similar to microfinance project engagement. The study,

that has been done in Polpithigama division of Kurunegala district, provides evidences for community

engagement and empowerment lead to the social progression in terms of economic growth at community

level. The findings of the study go onto say that financial situation, social position of the villagers have

been improved and discrimination against them has reduced as a result of the saving group activities.

Despite these positive impacts of the self-helping activities through savings, according to the study

findings, the social division based on the caste lines in two adjoint geographical areas are yet to be

harmonized in order to get the maximum out of programmes in this nature.

Bringing the debate of tradition and modernity into surface, third article explores the two major social

groups based on caste system are being evolving towards opposite directions. Taking an anthropological

path, this study digs into analyze the change and continuity of the Kandiyan social structure which was

initially divided vastly into low caste and high caste peasantries. The author carefully analyzes the

historical trajectories and path dependencies to conclude that the high caste peasantry has faced a critical

challenge to maintain the status quo while low caste peasantry maintains a constant upward social

mobility due to the market economy in which the group found a significant space for their productions

and the free education system through which they are climbing the ladder of the 'prestigious social status'.

This article and previous article provide a viable platform to analyze differently divided caste based social

groups in two contexts utilize the economic means to overcome their social bondages and their ultimate

outcomes.

The fourth article of this issue provides the outputs of a research which was conducted to analyze

beneficiaries' perceptions of school counselling program in the education system of Sri Lanka. The author

has aimed at accomplishment of three goals. They are: (1) recognize students' observation on school

counseling service, (2) discover the issues face by students in accepting this service and (3) the nature of

the counseling service that the students expect to obtain from the school. One of the major observations

of the students on school counselling is that senior school teachers have found a way to advice the

students in the name of counselling. The major drawback of the existing school counselling according to

the study is that its lack of professionality and confidentiality and lack of awareness of the students on

such a service. Hence, the author points out the need of professional counselling service that can

maintained the confidentiality in forms of school and individual counselling.

The combination of multi-area of research in this nature make the focal aspiration of the journal viable

and alive. All articles basically identify worthy research gaps and try to create a rigorous discussion both

at academic and general societal levels. For their effective endeavor, the editorial committee offers the
